Ready to shoot off some fireworks?!?!

Here's what you need to know...

Discharging of fireworks are allowed July 1,2,3,4,5 from 10:00 AM until 11:59PM so long as they are at least 25 feet from a permanent structure, no burn ban is in effect for Logan County, and all debris is picked up and disposed of properly. Please keep safety as a priority and stay clear of trees and roofs! Keep in mind many dogs are very fearful of the loud noises created by fireworks. Keep a close eye on your cherished family pet as many animals run away and get lost due to getting scared of a firework display.
